iLight portfolio

Date of this End of Life announcement: May 20, 2025.

Signify herewith announces the end of sales of the iLight portfolio as per September 1, 2025 (the "End of Sales Date").

This announcement relates to the complete hardware, software and services portfolio under the iLight brand, of which the currently available products, software and services are described on the iLight website.

After this date, it will not be possible anymore to order or purchase iLight products, licenses or subscriptions to software and services, except as indicated in this End of Life announcement.

iLight Hardware

Delivery dates for hardware products ordered before the End of Sale Date will fall on or before December 23, 2025 as to be planned in consultation with Signify.

Warranty commitments of Signify with respect to iLight hardware products purchased on or before the End of Sale Date, will continue to be honored in accordance with their terms.

For a period of five (5) years after December 23, 2025 (the "Replacement Period"), Signify will use reasonable commercial efforts to offer replacement hardware products for Defective Products (as defined in the <u>Standard Warranty</u> for iLight Networked and Standalone control products) that have been purchased before the End of Sales Date against the then current price and terms and conditions. The warranty term of any such replacement hardware products will never go beyond the end of the Replacement Period.

Official partners are entitled to ask technical questions about the iLight hardware to System Experts via MyLighting portal as currently. This support will be available for five (5) years after the End of Sales Date.
